

FINDING AID: TWELVE ANGRY MEN (2004) PRODUCTION FILES

Scope and Content

Production Files span two Hollinger boxes consisting of 23 folders, 3 Playbills, marketing flyers, the cast/family photo, and five amateur snapshots of the set with and without actors on it (two with film negatives stapled to them). There are also three photo prints of a color pastel drawing of the 12 characters in the juror's room, which appears to have been created as promotional material for the production. The drawing may not have been used for the American Airlines production, but there is a related use agreement folder in the "Twelve Angry Men" tour files.

Digital holdings include the following folders:

Costume Sketches (includes costume study sketches, fabric swatch digital image and measurement sheets)

Education (contains study guide)

Management (digital copies of contacts, backstage memos and director's notes--may be restricted access)

Marketing (advertising image)

Media (mp3 files of interviews with Allen Moyer, Michael Krass, and Scott Ellis; also press kit, radio spots, and XM Satellite clips)

Opening Night Gift (jpeg image of an engraved gavel)

Performance Reports (Word .doc files of some reports)

Playbill (20 jpeg scans)

Press (video file and select Archive-scanned press)

Production Photographs (captioned selects only)

Show Art

Tour (exterior, marquis and lobby photographs from each tour location, as well as actor selects of George Wendt and Richard Thomas. Also video clips of commercials and the tour poster)
